Perth Amboy Board of Education Negotiations Update

October 29, 2019

On Tuesday, October 15, 2019, the Board negotiations committee accepted guides which were proposed by the AFT leadership. The Board felt that these guides would provide the district staff with the agreed upon increases, while ensuring that all staff members received an equitable increase over the course of the contract. The Board's goals were to provide each staff member with an increase of 3.5% in the first year of the contract and minimum increases of 3% in the second and third year of the contract.

On Thursday, October 17, 2019, the AFT attorney informed the board attorney that there was an error in the guides that the AFT had submitted and the error needed to be corrected as the AFT would not recommend their guide to their membership. The board was prepared to accept these guides at the board meeting scheduled for that evening, however since the AFT needed to correct the error, the board meeting was cancelled.

On Friday, October 18, 2019 the AFT, once again, submitted guides for the Board to consider. After a review of these new guides, the Board rejected the certificated salary guides proposed by the AFT leadership, which were reviewed by the district's auditor, for the following reasons:

- Under the guides proposed by the AFT negotiations committee, approximately 26.50% of our staff or 270 certificated staff members would not receive the minimum of 3.5% increase in year one of this contract.
- Approximately 7.8% of our staff or 80 certificated staff members would not receive a minimum of 3.0 % increase in year two of this contract.
- Under the AFT committee's proposed guides, approximately 28% or 282 staff members would receive between a 15.48% to 26.31% salary increase over the 3-year life of this contract. This would be at the expense of other certificated staff members.

An example of this is: staff on Steps 11 and 12 BA column, which consists of approximately 40 employees, would receive a salary increase of in excess of 26.00% over the life of this contract.

Another example is: staff on Step 12 MA column, which consists of about 28 employees, would receive a salary increase of approximately 24.50% over the life of this contract.

- An employee currently on Step 5 (17-18), who would move to Step D in the first year on the agreed upon guide (18-19), would earn \$55,545, during the first year. That same employee would earn \$53,640 on the AFT corrected guide. This is a difference of \$1,905. Over the course of this contract, this employee would earn \$2,805 less on the AFT corrected guide than they would on the agreed upon guide.
- Under the new revised guides, the AFT deducted in excess of \$470,000 from proposed steps 1 through 10 on the AFT submitted guide dated October 14th and added it to the AFT's proposed steps 11 through 15 in year 1.

We believe that our teachers deserve better, which is why we did not approve the guides as submitted.

Today, October 29, 2019 at 3:17 p.m. we received revised salary guides from the AFT attorney. These will be forwarded to our business office and auditor to review and analyze. If they are fair and equitable, we intend to approve them at the next Board meeting.


