- 5. Meeting open to the public for discussion of agenda items.
  - Public member #1 spoke about curriculum item #7 the school calendar. She stated that the staff recently received a letter from Human Resources stating that anyone who wishes to take a day off for a religious observance must use their personal time.     this. It's a decision and if you use up all your days, people can be reasonable, discussions could be
    had. Common sense should be used when making up the calendar.
  - <u>Public member #3</u> spoke about curriculum item #7 the school calendar. The bigger issue is that the union and the board always sat together to discuss the calendar. When Dr. Caffrey came to the district she broke the calendar and didn't take suggestions from the union. By not sitting with the union you don't sit with these people that are here this evening. You should get out from behind that table and meet with the people.

- This person also asked about 584 Charles Street: what is our appraisal; do we have an appraisal from the current owner; how many parking spaces will be developed from the purchase and demolition of these homes and could we utilize the back of the school for parking?
- Public member #2 has been a teacher at Shull School for 28 years. She's put in extra hours, but it never occurred to her to keep track of them. Last year she had to submit artifacts of her time spent at work and now she keeps a journal. In her journal she recorded the time she spends on grades, grading test papers, speaking with parents, entering information in the parent portal, designing projects, researching the internet for school projects and school work for the kids, working on lesson plans, dealing with students and how they are doing and getting set for the next day. Teachers use their own money for student and staff supplies. She's logged 45 hours just getting ready for school. It's a lot of hours. It's all certified staff, administration and non-certificated staff in the labor force. It's not a decent contract; we will be taking a pay cut. Can you look at her and say she's not worth pay that's hers? How could anyone tell teachers to work 83 hours of unpaid overtime. The restoration of fully paid health benefits and a raise is what we need, not a pay cut.
- Public member #3 stated that chapter 78 expired, but not really as it's still in effect halfway. Both sides need to be fair with realistic goals. She's here all day and she's here for the kids. The health law was set up by Trenton, not the board or the superintendent. We need to see a reasonable amount for this. NJEA has been told that we can't vote on this contract. If you're all professional's than treat people that way.
- Public member #4 she's been in the district for 34 years. This is the fourth contract she's been part of negotiations and she's never been involved where the Board of Education members have had to leave early. The AFT is always prepared to stay. We've never been told here's your proposal if you don't like it too bad. Please clear your calendar so we can meet.
- Public member #5 is a junior who spoke about PARCC. She's worried that by taking the PARCC exam her AP classes will be affected because she won't be able to spend time in those classes. She asked the board to please review the schedule to see if something can be done so students don't suffer by losing their classes.

Tejeda Motion Puccio Seconded (To close public business) CARRIED UNANIMOUSLY

A motion to adjourn was made at 8:22 pm by Mr. Varela and seconded by Ms. Tejeda. Carried 17. unanimously.
